Food Additives:

For products covered under this standard, specific food additives permitted in Appendix 'A' (FCS 2.1.2) of these regulations may be used and only within the limits specified.

Contaminants, Toxins and Residues:

The product shall comply with the limits stipulated under the Food Safety and Standards (Contaminants, toxins and Residues) Regulations, 2011. The product meets specifications of Heavy metals (2.1.1, Lead, Arsenic, Cadmium, Mercury), Total Aflatoxin and Aflatoxin B1 (2.2.1) and pesticide residues (2.3.1, banned pesticides) to be met.

- ix. Annual turnover statement to be furnished by chartered accountant and it should be more than **2.90 crores (Average of last 3 financial years).**
- x. Experience proof of having supplied 13,500 tins/2,03,000kgs of Gingelly Oil in any year during the last three years (copies of invoices/way bill should be uploaded)

2. The Tenderer should upload **EMD** through online payment at least one working day prior to the date of e- Tender.

3. The Tenderer should submit a lab report that confirming to the tender specifications of TTD as mentioned at tender condition No. 19. The lab report shall be issued by the any of the NABL accredited lab only.
