- 1. The bidder shall submit response through Bid submission to the tender on e-Procurement platform at www.apeprocurement.gov.in by following the procedure given below. The bidder would be required to register on the e-procurement market place www.eprocurement.gov.in (or) https://tender.eprocurement.gov.in and submit their bids online. Offline bids shall not be entertained by the Tender Inviting Authority for the e-tenders published in e-procurement platform.
- 2. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc., in the online standard formats displayed in e-Procurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/technical bids and other certificate/documents in the e-Procurement web site. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity. The bidder shall attach all the required documents for the specific tender after uploading the same during the bid submission as per the tender notice and bid document.

### **Hard copies:**

- i. Attested copies of all original hard copies of the uploaded scanned copies of D.D towards EMD by participating bidders must submit along with <u>samples of annexure of specified sizes</u> for each item sample of the product / commodity to the tender inviting authority before scheduled date and time of the opening of the Technical bid, otherwise the tender will be rejected on online.
- ii. All the bidders shall invariably upload the scanned copies of DD in e-Procurement system and this will be the primary requirement to consider the bid responsive.

1. Online (e-tendering) short e-tenders are invited for "Rimming works with tape pasting to Regular Calendars-2025. SV(Big), SV&SP(Small), SP(Big), Local & Outside Temples, etc., Calendar-2025". The T.T.D. is inviting e-tender in two bids i.e., (1) Technical bid & (2) Financial bid. The tenderer should have been executed work in this trade for not less than (1) one year in the last (3) three years and should have executed work in any reputed institution (or) institutions as the case may be. A copy of the work executed/work order for having supplied bulk quantities, have to be scanned and uploaded for technical bid evaluation by TTD. The interested tenderers are also required to submit for samples of specified sizes as samples. - **16.** The rates quoted for each item by the Tenderer will be treated as inclusive of all taxes including GST and allied taxes etc., **The Gauge of the Rim should be of 1.2 mm with tight grip of the Calendar.**
