 - b.Registration of the firm.
 - c. GST registration
 - d. PAN card & Income Tax returns for the last preceding 3 financial years.
 - e.Self-declaration certificate (Annexure-B).
 - f. Declaration agreeing to abide all the terms and conditions of tender as per (Annexure-A)
 - g.20 samples shall be submitted at the time of tender and Annexure -C.
 - h. Supply of the relevant commodity experience in proof of evidence of supplies made to the different organizations in each year of last three preceding financial years period (proof of clear invoices/ way bills showing experience should be uploaded).
 - i. Self-Declaration letter to the extent that they have not been black listed in any of the organizations.
 - j. Letter towards authorized signatory to sign and submit bid in the case of Dealers etc.,

- **8.** The entire document of NIT should be signed by the authorized representative of the firm and the same should be submitted to online.
- **9.** The tenderer should furnish documents (invoices / e-way bills) for the past experience of supplying of 10 Lakh Nos of the same product to different organizations in any one year of the last 3(three) financial years.
