9. All bidders shall furnish the original hard copies of the on- line payment copy for EMD before PQ stage opening date and time fixed.
10. If any bidder fails to submit the original hard copies of the on- line payment copy for EMD within the stipulated time, they will be technically dis-qualified and the Initial Price Offer of the respective bidder will not be opened.
11. The Department shall carry out the technical bid evaluation solely based on the uploaded certificates / documents, on- line payment copy for EMD in the e-procurement system and open the price bids of so received.

1. The sales Annual Turn Over of the Manufacturing Medical Companies participating in Medicines Tenders shall be over and above Rs. 200.00 crore per annum for the last 03 Financial Years. In case of Surgical and Consumable etc., Tenders, the sales Annual Turn Over of Manufacturing Companies shall be over and above Rs.50 Crore per annum for the last 03 Financial Years. A certificate to that effect certified by the Chartered Accountant in their letter head shall be obtained and uploaded in the Bid. If the Manufacturers are quoting, then they can quote only for the products being manufactured by their company. In case of authorized distributors/importers participating in Tenders, their Annual Turn Over shall be more than Rs.2.00 Crore per annum for the last 03 Financial Years. For authorized distributors/importers, the annual turnover shall be from the sales of related items like drugs, medicines, lab items and surgical items etc., only. A certificate to that effect certified by the Chartered Accountant in their letter head shall be obtained and uploaded in the Bid. Further the authorized dealers shall upload and submit authorization letter from the actual Manufacturer.
2. **EMD:** Every Tender must be accompanied by Account payee on-line payment for Rs.25,000-00 (Rupees Twenty Five thousands only) through any Scheduled bank in account of the Executive Officer, TTD, Tirupati towards refundable Earnest money Deposit drawn after notice inviting Tender date. The EMD on-line payment copy must be scanned and uploaded along with the Technical Bid. Bank guarantee, postal orders and cheques or any other mode of payment shall not be accepted. The E.M.D. amount will be adjusted towards the full EMD for the successful bidder without interest.
3. Tenders not accompanied by the Earnest Money Deposit as above will be summarily rejected.
4. No claims shall lie against the TTD in respect of interest on Earnest Money Deposit and TTD shall not pay any interest on the Earnest Money Deposit.
5. **Security Deposit:** The successful Bidder shall pay Security Deposit @ 2.5% to the total value of Supply of Medicines, Lab and Surgical items in respect of items entrusted to them in full without any concession, in the form of demand Draft/BG drawn in favour of the Executive Officer, T.T.D, on any Scheduled bank payable at Tirupati, at the time of the agreement. This will be refunded only after the completion of supply of medicines or at least 80% of the ordered Medicines in the PO and also will be forfeited if the tenderer fails to supply the medicines as per the TTD's indent or supplies inferior quality of medicines or fails to follow the schedule as mentioned in each LOI as issued by the SMO from time to time during the valid period of agreement. Each successful bidder has to enter into an agreement with the TTD with the terms and conditions prescribed upon.
6. The supply of material will not be accepted till the Full Security Deposit criteria at 2.5% on the total value of supply order is fulfilled and agreement is concluded. The Earnest Money Deposit will be released only after successful completion of the supply in all respects. The EMD will not carry any interest.
7. The transaction fee to e-Procurement portal is to be paid at scheduled date of e-Tender. Those suppliers who are qualified by submitting the required documents including EMD and transaction fee alone, will be allowed to bid in the e- Tender on the date and time as to be intimated to the eligible bidders. The T.T.D. may extend the last date by issuing an amendment, in such case, all rights and obligations

of the T.T.D. and the suppliers previously subject to the original deadline will apply without any modification, which is subjected to the new deadline.

8. The transaction fee indicated in SI.No.13 of Annexure-A is to be paid to Government of Andhra Pradesh escrow account of at least one working day prior to date of e-tender.
9. The supplier should possess all requisite licenses, registrations etc., and the same should be obtained invariably before transacting business with TTD. The supplier should inform TTD, the correct address from where the supplies are going to be made to TTD. The supplier should have an experience of three years in this field and the certificate from the CA (as per proforma) and other certificates like GST registration should submit at the time of registration / participating as Vendor with APTS e-procurement portal. In case of non-submission of these certificates, the TTD authority reserves the right to take any appropriate action including cancellation of tender of the respective supplier. In this regard the decision of the TTD is final and binding on the suppliers without any recourse.
10. The Bidders are requested to quote their best competitive rates as there is no negotiation and in this regard the decision of TTD shall be final and binding on the suppliers without any recourse.
11. The received bids through e-Tenders by the Senior Medical Officer, T.T.D., Tirupati, or by any other officer authorized by him.
12. The Tender Inviting Authority, T.T.D., Tirupati may be approached for details and clarification if any, till a day prior to the opening date of Tenders.
13. The successful bidder shall submit the Security Deposit to the Tender inviting authority for concluding the agreement. The department will not hold any risk and responsibility for non – visibility of the scanned documents. The documents that are uploaded online will only be considered for bid evaluation.
14. Tender document:

The bidder is requested to download the tender document and read all the terms and conditions mentioned in the tender Document and seek clarification if any from the Tender Inviting Authority. If the tender assumes certain thing and quote the tender without seeking clarifications, it will be at their own risk. Any offline bid submission clause in the tender document could be rejected.
15. The Tenderers shall enclose the following documents for evaluation of Technical Bid.
 - a) Valid proof in support of manufacturers/ Authorized dealers of the companies mentioned in ANNEXURE-A with minimum 3 years of experience in the related trade.
 - b) Earnest Money Deposit by way of online payment for Rs.25,000/- drawn in favour of "The Executive Officer, TTD, Tirupati from any Scheduled Bank payable at Tirupati" drawn after the Tender inviting date.
 - c) Copy of GST registration certificate and copy of PAN Card of the firm or supplier.
 - d) A copy of Good Manufacturing Practices (GMP) certificate of the firm issued by the Drug controller authorities.
 - e) Annual Turnover Certificate for more than Rs.200.00 crores during last three Financial Years i.e. 2022-23, 2023-24 & 2024-25 certified by the Chartered Accountant only in their letter head. (Do not enclose Annual Reports/ financial statements etc.,). In case of Surgical and Consumable etc., Tenders, the sales Annual Turn Over of Manufacturing Companies shall be over and above Rs.50 Crore for the last 03 Financial Years. In

case of suppliers participating in Tenders their Annual Turn Over shall be more than Rs.2.00crore for the last 03 Financial Years. A certificate to that effect issued by the Chartered Accountant in their letter head shall be obtained and uploaded.

- f) Self-declaration in Rs. 100/- Non-Judicial stamp paper stating that the firm is neither convicted nor blacklisted/ No vigilance/ CBI / FEMA/ACB/CBCID Case pending against the firm as on the date of quoting for this work by any Hospital / Institution.
- g) **The Tenderer shall sign on all the pages of schedule and in last page signature and seal to be affixed. This Tender Schedule is to be uploaded.**
- h) Items should be quoted as per given specification only. If there is any deviation found then the tender of that particular participant will be summarily rejected. The tender with any pre conditions/past conditions/ assumptions/ presumptions etc., will be summarily rejected.
- i) All Technical details shall be mentioned in Technical Bid only. Please do not mention any technical details in Price Bid.
- j) **Drug Price Control Order (DPCO):** The price quoted by the tenderers shall not, in any case exceed the Drugs Price Control Order (DPCO) controlled price, if any, fixed by the Central/State Government. Tender Inviting Authority at its discretion, may exercise, the right to revise the price at any stage so as to conform to the controlled price as the case may be. This discretion will be exercised without prejudice to any other action that may be taken against the Tenderer.
16. The T.T.D., reserves the right to accept or reject any Tender and to cancel the process and to reject all Tenders at any time prior to the award of the contract without assigning any reasons and also under no obligation to inform the affected bidders the grounds of acceptance or rejection of the same. In this regard the decision of the Appropriate Authority in T.T.Devasthanams is final and binding on the Tenderer without any recourse. Further it is understood by both the parties to the Tender and is specifically accepted by the Tenderer that when the Tenderer files the Tender before T.T.Devasthanams, the acceptance or rejection of the Tender by T.T.D or methodology adopted by T.T.Devasthanams in short listing the companies for the supply of Medicines, Lab, Surgical Items etc. shall not become a cause of Action or Ground to initiate any Legal action before any Court or Courts of law for obtaining any order, Injunction, Direction etc., from the Hon'ble Court or Courts to stall the proceedings in T.T.Devasthanams.
17. The rate quoted per unit (unit as specified in Tender price schedule) should be F.O.R. Door delivery to O/o the Senior Medical Officer, CDS, TTD, Tirupati and inclusive of all statutory taxes (Excluding GST), all other levies and duties etc., Packing, Forwarding to destination in A.P., insurance, Storage, Transportation, Loading, Unloading, License Fees, Octroi, Road permits, e-way bill etc., TTD CANNOT ISSUE STATUTORY FORMS LIKE FORM "C" OR FORM "D" ETC., AND THIS SHOULD BE TAKEN INTO ACCOUNT BY THE SUPPLIER WHILE QUOTING THE RATES TO TTD. Further the supplier should possess all requisite licenses, registrations etc. to be obtained from various statutory departments before transacting the business with TTD and submit copy of GST Registration certificate. However the GST actual payable will be reimbursed by TTD on proof of payment of GST and GST applicable only shall be paid and if GST is paid more than the GST allowable then payment will be restricted to GST allowable only. The variation in GST percentage based on the actual and allowable will be permitted during the tenure of the supply agreement.
18. Even after any changes contemplated in the tax structure (other than GST) and the rate of taxes to be levied by the State Government & Central Government, the rates Quoted to T.T.D. should be constant during the agreement period of two years period and it should be applicable to all supply orders placed by TTD in two years contract period.
19. The rate quoted should be valid for acceptance for a period of 120 days from the date of opening of financial bid in e-Tender.

20. TTD Is a Charitable Institution rendering free Medical aid to the pilgrims who are visiting Tirumala to worship LORD VENKATESWAR SWAMY, Free treatment, Surgeries, Artificial Limbs & Calipers to Polio & Physically handicapped patients coming from all over India. Also Free Medical aid to the TTD Employees, their dependents & TTD Pensioners is provided. Hence the MEDICAL COMPANIES ARE REQUESTED TO QUOTE RATES FOR THEIR PRODUCTS DULY ALLOWING MAXIMUM DISCOUNT TO THE POSSIBLE EXTENT.
21. The tendered quantity is tentative. It can be increased or decreased at the discretion of the TTD.
22. **Risk Purchase**:-If the L1 supplier fails to supply ordered items even up to 45th day, the L2 Supplier will be asked to supply the items either at L1 rate or at the rate quoted by him. If L2 supplier agrees only the rate quoted by him then in such case the differential amount will be reduced from the L1 supplier payment bills or from the SD / EMD.
23. *Apart from the regular tender L1 supplier the other participants will be asked for their willingness to supply their quoted product at tender L1 price (agreed L1). In case the tender L1 fails to supply the subsequent orders will be placed on agreed L2 suppliers. If other bidders are not agreed to supply at L1 prices, the difference amount will be deducted from L1 supplier after placing the order to the next bidder/supplier.*
- a. The bidder has to quote same price for similar items for all TTD hospitals. If any item available less than the lowest quoted tender item, TTD hospitals has the right to purchase at that price.
24. The manufacturers who are participated directly in the tender, the manufacturer can directly supply or they can supply through any authorized distributor. In case of any conflict and supplies are affected, the manufacturers are authorized to identify another distributor and continue the supplies. This will be accepted only on submission of authorization letter and valid distributor documents by the manufacturer. (Duly fulfilled in the tender conditions)
25. The proposed items and quantities are the tentative requirement for use in TTD Hospitals. As per the exigencies and requirement all items may not be used by TTD Hospitals. Accordingly, the letter of acceptance will be issued for the required items only by the TTD Hospitals and this will not alter the tender decision of deciding the best price for all items as the tender is decided on item wise only.
26. Supplies will be received once in 06 months or at any shorter or longer intervals as decided by TTD during the tenure of the contract. Every consignment of materials shall be supplied within 45 days from the date of receipt of order by the successful tenderer from the TTD. In case of standing orders to supply within the stipulated period (or) delivery schedule issued or as indicated in the purchase order, the same shall be strictly followed.
27. The supply should be affected strictly as per delivery schedule to be given spread over to twelve months as the case may be. The schedule is tentative and the T.T.D. is having every right to revise the schedule depending upon the consumption.
28. The T.T.D. also reserves the right to increase the tender quantity by 15% on the same terms and conditions even after the tender period. In other wards increasing the tender quantity by 15% can be made by TTD even after the completion of the tender period and it is binding on the supplier without any recourse.
29. Pre dispatch inspection of drugs can be made by TTD at its discretion or by any agency entrusted for that purpose by TTD at the premises where from the supplies are being made. However this pre dispatch inspection will not obviate the inspection of material upon receiving at Drug stores at Tirupati. Further TTD reserves the right to send the medicines/surgical items supplied by the supplier for quality testing to any of the reputed labs in India. Handling, material and testing charges will be deducted by TTD from the payment payable to the successful tenderers for the above purpose.

30. Analysis Report on Medicine items of drug either Manufacturers Own lab / Govt. Recognized Lab should be enclosed during supply along with stocks of the particular batch supplied.

31. Procedure for Quality Testing:

- i. As and when deemed necessary, samples will be obtained and subjected to necessary quality testing. All the necessary expenditure including supply of samples shall be borne by the tenderer.
- ii. The Tenderer must submit an Analysis report as and when the quality testing committee (QTC) / Pharmacy Therapeutic committee (PTC) asked for in the event of random check or sampling of drugs within 10 days. In case of failure on part of the supplier to furnish such report, the batch of drugs will be returned to the supplier and he is bound to replenish the same with Govt. approved lab test report. The Drugs supplied by the successful Tenderer shall be of the best quality and shall comply with IP/BP/USP and the specifications, stipulations and conditions specified in the tender.
- iii. The QTC/PTC is authorized for random check or sampling of drugs. The Items having suspicious will be sent for quality testing labs with their remarks through Asst. Director Drug Control Authorities (DCA).
- iv. The Medical Items shall have the active ingredients at the Maximum permissible level throughout the shelf life period. The samples will be drawn periodically if required for testing.
- v. If any discrepancies found, the action should be taken as per the instructions of the committee.
- vi. If found chipping discoloration, precipitation, particles, improper packing etc. the committee will disqualify the item and recommended for withdrawal, black listed for 2-3 years. The cost of the batch supplied will be stopped apart from imposing other penalties.
- vii. In the event of the samples of Drugs supplied fails in quality tests or found to be not as per specifications, the Purchaser is at liberty to make alternative purchase of the items of drugs for which the Purchase orders have been placed from any other sources or in the open market or from any other Tenderer who might have quoted higher rates, at the risk and the cost of the supplier and in such cases the Purchaser has every right to recover the cost and impose penalty as per the decision of the CPC.
- viii. The products should conform to the standards of IP/BP/USP as the case may be. However, the drugs notified in the IP (amended up to date) shall be accepted only if supplied conforming to the standards outlined in the IP. In case the product is not included in the any of the said compendiums, the supplier, upon award of the contract, must provide the reference standards and testing protocols for quality control testing. For imported drugs, respective Country's Pharmacopoeia standards shall be acceptable (even if the product is official in IP).
- ix. The case of admixture of drugs will be treated as a violation of tender conditions. If such lapses happen more than twice in a tender period such cases will be treated as "Misbranded Drugs".
- x. The supplier shall furnish evidence of the basis for shelf life and other stability data concerning the commercial final package on request by the Purchaser. In case of any complaint in the field, the B.M.R/B.P.R for the particular batch of the product(s) supplied shall be produced when demanded.

32. In the event of the firm not making supplies within the stipulated delivery period, the TTD reserves the right to purchase the items or substitute (s) from any other source and the extra cost thus incurred by TTD will be recovered from the supplier in addition to the recovery of appropriate penalty as decided by the Management as the case may be from the deposits or bills payable to the supplier without giving any separate notice for recovery. T.T.D. also reserves the right to blacklist and debar such suppliers from participating in future supplies to TTD.

33. Saving Clause: No suit, prosecution or any legal proceedings shall lie against the

Purchaser, which is done in good faith or intended to be done in pursuance of tender. The Purchaser reserves the right to make modification, alteration or relaxation in any of the clauses or conditions given in this tender document.

- 34. Resolution of Disputes:** If any dispute or difference arises between the parties relating or concerning or to interpretation of the contract or any alleged breach thereof or any matter relating to the contract, the same shall be settled by the parties as far possible by mutual discussion and consultation between themselves, whether the same has arisen during the subsistence of the contract or thereafter.

In the event of any dispute arising out of the contract, it will be settled through mutual discussions and consensus failing which through arbitration as per Arbitration & Conciliation Amendment Act 2005, failing which through court of law within jurisdiction of Tirupati. ALL THE LAWS OF THE LAND WILL APPLY.

35. Late Delivery Charges (LDC):

Late Delivery Charges (LDC)-**General:** The successful supplier shall supply ordered items within 60 days from the date of release of supply / purchase order by TTD. The Late Delivery Charges will be levied on cost of supplies, @ 1% on supplies reaching the destination places from 61st day to 75th day and @ 2% on supplies reaching destination place from 76st day to 90th day. No supplies will be accepted after 5 pm of 90th day from the date of purchase order and in such a case, the agreement will be cancelled duly forfeiting the deposits. The LDC will be deducted from the payment bill or EMD as deemed fit by TTD. The TTD also reserves the right to cancel the agreement for the failure of keeping with the delivery schedule by the tenderers, in addition to this deposits along with the outstanding amount to the suppliers will also be forfeited.

- 36.** The TTD reserves the right to reject either the entire lot or part of the supply or impose cut, penalty or forfeit the EMD at its discretion if the quality is not strictly in accordance with the sample and specifications if any given by the supplier or of inferior quality goods if confirmed by Lab reports. In this regard the decision of Management, TTD shall be final and binding on the supplier. In addition to this the firm will be blacklisted for a period of 3 years from doing any business with TTD.
- 37.** The payment will be made only after the receipt of goods at TTD Hospitals in GOOD condition and should be strictly in conformity with the specifications.
- 38.** T.T.D. reserves the right to charge penalty as decided by the Senior Medical Officer or the authorities of officials to withhold payment for any unsatisfactory material supplied by the supplier without prejudice to its other rights. In this regard, the decision of Senior Medical Officer or authorized officials is final. The supplier is further liable to reimburse/compensate the TTD or to third party for any loss, damage, injury, harm etc., caused or arising out of the negligence in supply of low quality medicines, or any other act or breach of contract.
- 39.** Notwithstanding anything contained in the terms and conditions of this Tender, the TTD Management is the ultimate authority in deciding the recovery of percentage of penalty from the supplier taking in to account the stock position and future requirement of the supply in the larger interests of the organization.
- 40.** If the successful Bidder fails to execute the agreement and / or deposit the required SD within the time specified (within 15 days from the date of receipt of letter of acceptance of the tender) or withdraws his tender / Bid after the intimation of the acceptance of his tender/ Bid or owing to any other reasons, he is unable to undertake the contract, his contract will be cancelled and the Earnest Money Deposit deposited by him along with his tender/bid shall stand forfeited to the TTD and he will also be liable for all damages sustained by the TTD, by reasons of breach, such as failure to supply/ delayed supply, including the liability to pay any difference between the prices accepted by him and those ultimately paid for the procurement of the articles concerned. Such damages shall be assessed by the SMO, TTD or authorized officials whose decision is final in the matter. In addition to this the tenderer will also be proscribed from doing any business with TTD for a further period of 3 years along with the removal of the tenderer from the e-procurement site for a period of 3 years.

41. Packing Norms:

- (a) All medicines must be strongly and securely packed in for safe transportation/shipment in such a manner as to prevent damage and pilferage in transit, from the point of shipment to final destination.
 - (b) Metal parts wherever necessary shall be well slashed with preventives to prevent rusting in transit, or due to delay in Indian Port before clearing.
 - (c) All timber used in the packing of the materials is to be free from bark, insects and fungi.
 - (d) The medicines to be delivered in cold storage conditions shall also be properly dispatched in the same condition.
42. The packing of medicines should be in accordance with the provisions of packaging Act to avoid damages in transit. It should also contain marking to denote address, date of packing etc., for identifications.
43. Shortage and breakages will be intimated to the suppliers and the equivalent amount will be deducted from the bill amount, if they are not replaced by the supplier.
44. The successful Bidder shall supply latest manufactured Medicines, consumables, Surgical items and diagnostics etc., The supplied materials shall have long shelf life at the time of receipt of supplies at consignee end. In case of imported items as the shelf life is less than 50% at the time of receipt of supplies at consignee end, the stock will be accepted subject to utilization by the user Department of TTD Hospitals. If adulteration is noticed in the medicines the supplier will be prosecuted besides black listing the Firm and forfeiting the EMD.
45. Separate Stamping of any type like "For TTD Supply only, For Hospital Supply Only etc., " is not allowed on medicine Strips, Ampoules, Vials, Syrup bottles etc.
46. The prices quoted shall be final and fixed during total contract period. ANY REQUESTS FOR REVISION IN THE RATE OR RATES BY THE SUPPLIER SHALL NOT BE ENTERTAINED DURING THE RATE CONTRACT PERIOD EXCEPT FOR THE GST WHICH WILL BE PAID BASED ON THE PREVAILING RATES FROM TIME TO TIME.
47. Penal clauses of the supplier whatsoever like payment of interest on late payment of bills etc. shall not be acceptable to TTD. Any conditional tender also will be summarily rejected.
48. **Price Fall Clause:** If at any time, during the period of contract the price of quoted items is reduced or brought down by any law or by an act of the Central or State Government or by the supplier himself, the supplier shall be morally bound to inform the TTD Management immediately about such reduction in the contracted price or prices and the supplier shall be fair enough to transfer that benefit to TTD.
49. The successful bidder has to enter into an Agreement agreeing to all the conditions of the contract with the T.T.Devasthanams on Non-judicial stamp paper of value of Rs.100/- within 15 days from the date of receipt of the intimation to him that his BID has been accepted. The Format of Agreement shall be supplied to the approved supplier along with the communication of accepting the rates quoted. The written agreement initially to be signed by the successful tender and later by the TTD will be legal document between the two parties and binding on both of them.
50. Each supply should be accompanied by a bill along with Bank Account Details and Analysis report for arranging payment. The standard payment terms of TTD are applicable. No advance shall be paid by TTD against the order.
51. Supplies are to be made along with three copies of invoices. The invoice should contain item name (mentioned in PO.), Make, HSN Code, Batch No./Lot No., MRP, Expiry & Pack size (Wherever applicable) It shall be the responsibility of the tenderer for any shortages/damages at the time of receipt of stock in respective stores of the authority issued purchase orders.

52. The supplier is required to sign on all pages of Tender forms indicating name, date and affixing the rubber stamp with the designation or status enjoyed by the signatory in the business entity of the supplier, and the same signatory shall be required to execute agreement under his signature only. The signatory should produce documentary evidence of empowering him to do so, if called upon at any time during the contract period. In case of change in the Authorized signatory it is binding on the supplier to inform the changes to the S.M.O., T.T.Devasthanams/ Authorized official of the Hospital.
53. The Price Bids of Technically qualified Tenders are only opened. The date of opening of Price Bid is tentative.
54. If any Medicines, Lab, Surgical Items etc. supplied by the supplier have been partially or wholly used or consumed after supply and are subsequently found to be in bad order, unsound, inferior in quality or description or are otherwise faulty or unfit for consumption, then the contract price or prices of such Medicines, Lab, Surgical Items etc. will be recovered from the supplier, if payment had already been made to him. Otherwise the supplier will not be entitled to any payment what so ever for such supply.
For infringement of the stipulations of the contract or other unacceptable reasons, the contract would be terminated by the T.T.Devasthanams authorities, and the supplier shall be liable to pay for all losses sustained by the T.T.Devasthanams. In the consequence of the termination, the loss would be recovered personally from the supplier or other money due or may become due to him. 


