  - **8.** Self Declaration letter to the extent that they have not been black listed in any of the organizations
  - **9.** Letter towards authorized signatory to sign and submit bid in the case of Dealers etc.,
  - **10.** Annual turnover statement to be furnished by chartered accountant and it should be more than **2.90 crores (Average of last 3 financial years).**
  - **11.**Experience proof of having supplied 13,500 tins/2,02,500 kgs of Sunflower Oil in any year during the last three years (copies of invoices/way bill should be uploaded)
- 2. The Tenderer should upload **EMD** through online payment at least one working day prior to the date of e-Tender.
- 3. The Tenderer should submit a lab report that confirming to the tender specifications of TTD as mentioned at tender condition No. 19. The lab report shall be issued by the any of the NABL accredited lab only.
- 4. The entire document of NIT should be signed by the authorized representative of the firm and the same should be submitted to online.
